- 2. General Announcements: Cindy Cleghorn stated that Nathan from the City Clerk's office will go to the Community Improvement/Outreach meeting on 11/19/20, at 6pm.
- Discussion/<u>Action</u>: Approve the October Budget and Finance Committee meeting minutes. Claudia motioned Pati 2<sup>nd</sup>. All approved, no "Nays", No Abstentions
- Discussion/<u>Action</u>: Approve November 2020 Monthly Expenditure Report and Balances (MER). Pati motioned Claudia 2<sup>nd</sup>. As of this day, net balance is \$36,231.13. Zero outstanding as of this date. Expenses paid to date i: \$12,472.22. Roll call vote: All approved, no "Nays", No Abstentions
- 5. <u>Discussion</u>/Action: Budget and Finance Committee Member Pati Potter Excel Spreadsheet Balances. Pati shared the excel sheet she keeps that aligns with the balances on MER
- 6. Discussion/<u>Action</u>: Approve US Storage Rental increase for units #358 and #363 to \$243.50 per unit from \$224.50 per unit. Total \$468.00 monthly effective December 1, 2020. Nancy motioned, Claudia 2<sup>nd</sup>. Cindwasked if we will be able to downsize two units to one. Sandy and Lilliana had looked into this, and the folding chairs and apparatus that holds them take up too much room; so not at this time.
