- A lot of people are complaining about the lack of enforcement of Vending at HD Park Rangers/LAPD have been given the "hands-off-vendors" order nullifying any ability to enforce.
  - 1. The order arises out of a LAMC criminalization of vending w/o permit. Most vendors are illegal aliens. The Trump Administration has issued orders to deport illegal aliens with criminal records however minor
  - 2. "Hands-off-Vendors" is designed to avoid criminal records due to vending
