The ordinance will require all bins to get a building permit from the Department of Building and Safety to be installed and operated; can only be placed in commercial zones and they must be at least 100 ft. from any A or R zoned property, at least 10 feet from any property line, and at least 20 feet from a public right of way. No more than one collection bin is allowed on a property, which must have a main building with at least one operating business. The STNC LUC supports the draft ordinance.
