Item 16 on STNC's Dec 12 general meeting called for a "Review of conduct and bylaws compliance for committee chairs and members and possible actions".

When this item was taken up by the STNC Board the discussion strayed from a review of conduct and bylaws into a demand that Cindy Cleghorn be removed from the Land Use Committee. The "discussion" went on for an hour without any mention that an investigation had occurred identifying the details of what Cindy had actually done. No facts or evidence was mentioned. Some members of the board tried to moderate the discussion. One board member even called for a point of order, pointing out that agenda item 16 did not allow for the discussion to drift so far afield. That member was told to file a grievance. It seemed that some board members had already made up their minds. In other words the STNC became a kind of kangaroo court in which Miss Cleghorn was deemed guilty and should be removed.

Now a special meeting of the STNC board has been called for January 17, 2019 with agenda item 3 calling for the discussion and possible action to remove Cindy Cleghorn from the Land Use Committee.
