Senior Lead Officer (SLO) Cesar Contreras, Sunland – Looking forward to working with and supporting the new Board. There has been a 32% reduction in crime over last year, 89 fewer incidents. There are still sporadic car theft and burglaries. Crime tends to go up during summer when school is out and more people are outside, so always be aware and lock cars. The department is working on a chronic dump site / homeless camping site on City owned property, the City is looking in to making this site a pocket park or a community garden.

Dominique Vitti from CD 7 -- Monica Rodriguez opposes AB 516, she is coming up with a proposal that better addresses the problem. The council office has just opened a Homeless Family Resource Hub for homeless families in the northeast valley. The \$500,000 to open this facility was acquired through the state Homeless Emergency Aid Program (HEAP). North Valley City Hall is undergoing remodeling and Friday will be staff's last day in the facility. The phone number will still work. Sunland-Tujunga area staff will be located in Pacoima City Hall during the remodel. The Councilwoman has 10 movie nights planned for this summer; the first will be Shark Tale at Hansen Dam Recreation Center on June 21<sup>st</sup>.


