She further commented that the LAPD is having to cover for the lack of Park Rangers. LAPD now has to also cover the schools so they are spread very thin.

Marjorie Maxon read a statement to the committee. Lydia Grant noted that every single time the STNC is involved in any project, there needs to be acknowledgement of the STNC. All projects are considered Outreach, even Community Improvement. She further stated there had to be community input. We have many artists in this community- we just need to outreach to them. Lydia stated Committees are not independent groups- they are part of the STNC and everything being proposed by a committee needs to be approved by the STNC Board.
