Also ask how you can get a regular car to monitor the block.

Many times there are calls waiting, as many as 10, then hang up and try later, for that many it could be 1hr. but if you are working on your computer maybe ok to be on hold. 5 calls can be around 10-20 minutes sometimes.

Example: called in a truck for the first time they gave an option of a call back. This is something new.

### RESOLUTION

WHEREAS, any official position of the City of Los Angeles with respect to legislation, rules, regulations, or policies proposed to or pending before a local, state, or federal government body or agency must have first been adopted in the form of a Resolution by the City Council; and

WHEREAS, existing law identifies the California state highway system through a description of segments of roads that are owned and operated by the California Department of Transportation (Caltrans); and

WHEREAS, California State Route (SR 210) follows the foothills of the San Gabriel Mountains for approximately 85 miles, connecting the northeastern suburbs of Los Angeles with the Inland Empire; and

WHEREAS, on February 13, 2023, Assembly Member Holden introduced AB 776, which would require Caltrans to work with certain entities, including, but not limited to, California Indian tribes local to, or historically located along, State Route 210, to identify appropriate locations for signs to recognize tribal lands in Los Angeles and San Bernardino counties and designate the highway as the Southern California Native American Freeway; and

WHEREAS, AB 776 acknowledges the tribal cultural affiliations along Route 210 including Cahuilla, Chumash, Gabrieleno/Tongva, Fernandeño/Tataviam and Serrano and includes findings and declarations related to the role Native Americans have played in the state and country's culture and success; and

WHEREAS, the bill's acknowledgment of indigenous lands provides exposure and a learning opportunity for individuals who may have never heard the names of the tribes, acknowledges the land is indigenous/tribal protocol, and establishes a respectful routine and habit of supporting reconciliation;

NOW, THEREFORE BE IT RESOLVED, that by the adoption of this Resolution, the City of Los Angeles hereby includes in its 2023-2024 State Legislative Program SUPPORT for Assembly Bill 776 (Holden) that would require Caltrans to work with California Indian tribes local to, or historically located along State Route 210, to identify appropriate locations for signs to recognize tribal lands and designate the highway as the Southern California Native American Freeway.

# COUNCIL FILE NO. 23-0224 - RIVERWOOD RANCH COMMUNITY - ORO VISTA AVE CROSSING

### **SUMMARY**

To address the flooding and access issue on Oro Vista Avenue over the Tujunga Wash, Bureau of Engineering (BOE) staff met with the Council District 7 staff to discuss viable alternatives to the current low water crossing, also known as an "Arizona crossing" that passes water from high flows due to storm events. Upon exploring several potential options, BOE identified two alternatives that would provide "all weather" access to the Riverwood Ranch Community. Given the cost associated with each alternative, an indepth feasibility study would need to be conducted for all potential solutions outlined in this report.

### RECOMMENDATION

That the City Council RECEIVE AND FILE this report.

### **BACKGROUND**

Riverwood Ranch Community was established in the 1910's and currently consists of approximately 35 privately-owned parcels. The only paved access to the community is through Oro Vista Avenue, which crosses along the bottom of the Tujunga Wash. This low water crossing is also known as an "Arizona crossing," which is intended to allow water to pass over it during high flows from storm events.

In 1969, this section of Oro Vista Avenue was destroyed by a heavy storm event, and the homeowners filed claims against the City as a result. To settle the claims, a "by-road" was constructed per City Ordinance 140795 with reference to City Council Files Nos. 142557 and 70-1011. In 1970, the said replacement road and the bridge portion were constructed

as a low water crossing, per plan P-27075, with the understanding that the road would be unusable during storm events. Since then, City forces have maintained the Arizona Crossing portion of Oro Vista Avenue on an as-needed basis. To reduce the storm runoff overflowing Oro Vista Avenue, two 42-inch reinforced concrete pipe culverts were installed in 1996 to divert runoff underneath the roadway per plan P-34963.

There are small earthen berms and large boulders placed in the area adjacent to and along the margin of the road. These were placed for safety of the motoring public and the prevention of trespassing into the Wash area by motorized vehicles.

During times of high flow, the flowing water carries sediment, rocks, and debris onto and over Oro Vista Avenue. Under these scenarios, the resulting blockage makes Oro Vista Avenue impassable.

### **DISCUSSION**

In response to the motion from Council District 7, BOE staff evaluated various long-term Capital Improvement proposals and alternatives for preventing future access closure of Oro Vista Avenue through the Tujunga Wash. During the evaluation process, BOE recognized that the Tujunga Wash is a natural habitat for various native plants and animals, and any maintenance work to be performed adjacent to or in the Tujunga Wash would require permission from various regulatory agencies, which could result in lengthy permitting processes. Minimizing future maintenance activities in the Wash becomes an important consideration. BOE has identified two alternatives for potential further exploration:

- 1) Constructing an elevated roadway or bridge crossing over the Tujunga Wash that ranges from 750 feet to 850 feet long, depending on the final alignment, and
- 2) Constructing a roadway that meets City street standards along the existing 1.2-mile dirt road between Riverwood Drive and Foothill Boulevard.

For comparison purposes, the preliminary construction cost estimate for the elevated roadway or bridge alternative is approximately \$70 million. The preliminary construction cost estimate for the roadway alternative is approximately \$55 million. Each of these alternatives would require a mix of regulatory permitting from environmental resource agencies and real estate acquisition because the City does not have a right of way over the proposed locations. These efforts would require additional costs that we are unable to establish at this time. Given the nature of these complexities, a feasibility study would be required to investigate the constructability of each alternative in detail and consider additional factors including but not limited to: 1) right-of-way acquisition, 2) permit requirements, 3) environmental studies, 4) street lighting requirements, and 5) geotechnical studies.

### **FISCAL IMPACT**

BOE is working with CAO to identify potential funding sources for a feasibility study of these alternatives and will prepare a joint report once we have concluded our discussions. BOE estimates the cost of this study to be \$1 million.

### MOTION

The Riverwood Ranch community in Sunland was established in 1910 and currently consists of roughly 35 parcels. Oro Vista Avenue-connecting the residents of the Riverwood Ranch community to the Sunland-Tujunga area-serves as a paved access from this hillside community.

Its location within the Tujunga Wash and low traffic volumes, Oro Vista Avenue was built as an Arizona style crossing, which is a low-water culvert crossing where a road dips across a normally dry creek bed or drainage area. However, Oro Vista Avenue has become more prone to severe flooding during the wet weather season. In addition, the Big Tujunga Dam, located further upstream, must, on occasion, release water during extreme weather events, further exacerbating flooding in this area and isolating residents from access to emergency services during storm events.

The Big Tujunga Wash comes with its unique set of issues resulting from multiple jurisdictions having ownership along various segments of the Wash. It is therefore important to bring together all partners to identify solutions for better managing flooding and maintaining passable access during wet weather events.

I THEREFORE MOVE the Bureau of Engineering, Bureau of Sanitation, Bureau of Street Services, the Los Angeles Fire Department, and all other relevant City departments, report back to Council in 15 days with solutions for addressing the flooding and access issues at Oro Vista Avenue at Big Tujunga Canyon Road and improvements that will prevent future access closures.

I FURTHER MOVE the Bureau of Engineering, with assistance from the Office of the City Administrative Officer, report back in 15 days on available funding options for the needed improvements and continued maintenance cost associated.

Re: 2023-2026 Victim Emergency Assistance Program (VEAP)

Transmitted herewith for Mayor and City Council consideration is a 36-month grant award extension for the Victim Emergency Assistance Program (VEAP) provided by the State of California Victim Compensation Board (CalVCB). This extension will maintain a \$300,000 revolving fund intended to provide emergency financial assistance to victims and witnesses from July 1, 2023 through June 30, 2026.

VEAP provides financial assistance to victims and witnesses of crimes such as domestic violence, child and elder abuse, hate crimes, sexual assault, robbery and assault, drunk driving, hit and run, and homicide. Financial assistance includes payments for domestic violence relocation expenses, emergency expenses for victims of sexual assault, verified funeral and burial claims, and crime scene clean-up expenses.

The Office of the City Attorney's Victim Assistance Program (VAP), which is located throughout the City of Los Angeles, administers VEAP by maintaining a VEAP account from which it issues payments. Thereafter, the payments are verified by the VAP's Joint Powers of Verification Unit and submitted to CalVCB, who reimburses the City for its disbursements.
