5. INFORMATION / UPDATES: Pending Land Use Committee projects, led by Cindy Cleghorn

- a. <u>7665 Machrea</u> Subdivision into 7 single family dwelling lots, zoned RE3-1. LUC waiting for owner's rep to schedule a second meeting. Over 40 neighbors attended the Oct. 16 meeting with several major concerns regarding this many units on that site and the impacts to neighbors' quality of life.
- b. <u>9604 Hillhaven</u> addition to two story home and relief from 20 ft widening of street. waiting for owner & City response to building & street width concerns by neighbors & LUC.
- c. <u>7577 Foothill & Plainview</u> Neighbor has filed an appeal to proposed 42 feet high residential building with 46 dwelling units, 89 parking spaces. Former Denny's site. Awaiting a hearing to be scheduled by the City regarding the appeal.

6. PRESENTATION / SPEAKERS / Q&A : Safe Traffic & Transportation Committee 2024 New Year/2023 Review Updates and Recommendations to the STNC Board.

- Pat Kramer, STAT Committee Chair, drafted a letter (to LAPD Chief Moore and Mayor Karen Bass) asking for funding for a second second traffic officer for Sunland-Tujunga area using funding from other areas that have defunded officers. Pat provided historical information about requesting additional traffic officer presence that have not been completed by the City in the past.
- Justin Grams commented regarding funding re-allocation from other districts who want to defund police in their area.
- Susan Denning inquired if additional information could be put into the letter addressing car parking in the Foothill Blvd and Plainview Ave area? Pat Kramer suggested that Susan attend the STAT meeting in January 23rd to address her concern.
- Lionel Mares from Sun Valley Area NC commented that we need more resources to address the traffic concerns.
- Jon von Gunten commented that while some money has been re-instated, we lost many experienced officers.
- KT Travers would like to amend the letter to include specific numbers which are available for accidents.
- Cheryl Schmidt commented in support of motion.

- LAPD Officers Godoy and Alvarado provided crime stats and noted that use of the 311 App has been helpful. Officer Alvarado comment that Officer Andrew Reiny (new Traffic Control Officer) will be at next STNC meeting.
 - Cindy Cleghorn identified a tent (for homeless) parked on the street and asked about recent heavy helicopters circling in the area. Officer Alvarado will check on tent. Officer Godoy noted that the Homeless have been offered housing but in general do not avail themselves of it.
 - Susan Denning asked about Stocken windows/shattered safety glass (around 7560 Foothill Blvd). Officer Godoy has not seen any reports on it.
 - Cheryl Schmidt thanked officers for their support and indicated the need for continued/ increased surveillance four local parks.
 - Pat Kramar commented that cars that are dismantled and parked on LaTuna Canyon and the number of homeless is increasing around golf course. Officer Godoy indicated that the car issue is being addressed.
 - Jon von Gunten talked about Coffee with a Cop in February and details will be provided later.

- Michelle Vergara, Senior/East Valley Area Representative (Michelle.vergara@lacity.org), commented about accomplishments under Mayor Bass this past year. An App is available to stay in touch with Mayor Bass news -

- LAFD Battalion Chief Adam Knabe cautioned to be careful about firing up heaters at this time of the year and to safely dispose of Christmas trees before they dry out.
 - Leny Freeman voiced concern about La Tuna Canyon homeless camps and potential fire hazards.
 - Leny Freeman voiced a concern about Christmas Trees that accumulate in a bin and the potential fire hazard. Fire Station 77 has a bin where trees can be deposited.
 - Jon von Gunten thanked LAFD and wanted to know if there is any authority to get rid of Christmas trees on private property.
- Jack Artan, from Senator Portantino's office (covering for Declan Floyd), commented that the State Senate has reconvened, ideas for legislation are invited and talked about State budget deficits.
- Ricardo Flores, CD7 discussed traffic signals, breaking ground remodel of Verdugo Hills pool, and working on homeless issues at the golf course.

- Lydia Grant inquired about time-line for Oro Vista traffic signal? Ricardo said within the next 2 months should have more information.
- Jon von Gunten wanted to know timeline for activation of signal in front of Fire Station 77, Should be in February.
- Pat Kramer voiced a concern about Patrick returning to the community.
- There were also questions about traffic light at Valmont & Foothill and Apperson & Foothill with the new left-hand turn signals.
- Raul Preciado sent out updates and commented about Neighborhood Council funding training.
- From CHAT: LA City Park Ranger A. Deocampo (who had to leave early) Starting January 14th, we will have a new Park Ranger sergeant assigned to the Valley Sgt. Carl Holmes.
