**Subject:** Amendment to Require Bike Lanes to Provide Sufficient Width for Emergency

Vehicle Access

Position: OPPOSE

#### **Summary:**

The Sunland-Tujunga Neighborhood Council (STNC) has reviewed Council File 25-0930 regarding options and amendments to require that bike lanes provide sufficient width for emergency vehicle access. The original motion was introduced by Councilmember Heather Hutt and seconded by Councilmember Tim McOsker on August 13, 2025. The amendment was introduced by Councilmembers Hugo Soto-Martínez and Nithya Raman and seconded by Councilmember Katy Yaroslavsky.

#### **Community Position:**

The Sunland-Tujunga Neighborhood Council's STAT Committee unanimously approved a motion recommending that the STNC Board oppose this amendment. Our community does not believe this proposal would be practical or safe for the Sunland-Tujunga area.

Foothill Boulevard and Sunland Boulevard are already constrained by existing bike lanes and on-street parking, leaving limited space for vehicle traffic in both directions. Further restricting these travel lanes to accommodate emergency vehicles within the bike lanes would exacerbate congestion and reduce roadway safety.

Additionally, allowing emergency vehicles to use bike lanes poses a serious risk to cyclists, who could become trapped between fast-moving traffic and the curb during emergency responses. Such a policy would endanger both bicyclists and motorists rather than improving safety or emergency response times.

#### **Conclusion:**

For these reasons, the Sunland-Tujunga Neighborhood Council respectfully opposes the proposed amendment requiring bike lanes to provide additional width for emergency vehicle access.

Requirement / Registry Exclusion Position: SUPPORT IF AMENDED

At a duly noticed public meeting, the **Sunland-Tujunga Neighborhood Council (STNC)** voted to **Support If Amended** Council File 25-1152, which concerns disclosure and eligibility requirements for Neighborhood Council applicants who are registered sex offenders.

The STNC agrees that public safety and trust are fundamental to the integrity of the Neighborhood Council system. Neighborhood Council members often serve in public-facing roles, engage with youth and families at community events, and represent their neighborhoods in civic discussions. It is therefore reasonable that the City consider policies to prevent potential risks and uphold public confidence.

However, as written, this proposal raises questions about implementation, fairness, and privacy that require careful review and clarification. The STNC recommends that amendments include the following:

- 1. **Consistent Citywide Policy:** The City Attorney and Department of Neighborhood Empowerment (DONE) should develop uniform, citywide guidelines applicable to all Neighborhood Councils to avoid unequal enforcement or confusion.
- 2. **Clear Definition of Disclosure Scope:** The policy should specify when, how, and to whom any disclosure would be made—balancing the public's right to safety with legal privacy protections.
- 3. **City Oversight, Not Local Enforcement:** Neighborhood Councils are volunteer advisory bodies and should not be placed in the position of collecting, storing, or evaluating criminal background information. Any verification or exclusion process should be handled by the appropriate City department, not by individual councils.
- 4. **Training and Legal Protection:** DONE should provide mandatory training on confidentiality and liability protections for board members and election administrators to prevent misuse or discrimination.
- 5. **Pathways for Rehabilitation and Participation:** The City should explore options for appropriate participation that do not compromise safety, such as advisory or virtual roles that do not involve direct public interaction.

The STNC supports the **intent** of CF 25-1152 to ensure community safety and transparency but urges the City Council to **amend the motion** to include these clarifications before adoption.

#### Zone 0 – Ember-Resistant Defensible Space (At a Glance)

Updated: November 2025

The State of California and the Los Angeles Fire Department are implementing stronger defensible space standards in Very High Fire Hazard Severity Zones (VHFHSZ). These new "Zone 0" rules focus on the first 0–5 feet around your home to reduce ember ignition risk. What is Zone 0?

- The area within 0–5 feet of a structure must be kept clear of combustible materials.
- No wood mulch, firewood, or wooden fences touching walls.
- Use non-combustible hardscape, gravel, or concrete.

Why It Matters

Embers are the leading cause of home loss in wildfires. Zone 0 reduces ignition risk and increases firefighter safety.

Executive Order N-18-25

Governor Newsom's order (Feb 2025) accelerates rulemaking for Zone 0 statewide under PRC §4291 and GC §51182. The Board of Forestry must complete regulations in 2025.

City of Los Angeles Next Steps

• LAFD and CFAC are reviewing how to apply Zone 0 within Los Angeles.• Public outreach and guidance materials will be released.• Residents in VHFHSZ should prepare for compliance and inspections.

**Board Motion** 

The [Neighborhood Council] finds that the Los Angeles Fire Department's updated Fire Zone resources and the State's accelerated "Zone 0" ember-resistant defensible space rulemaking under Executive Order N-18-25 are vital to reducing structure loss and improving community safety in Los Angeles' Very High Fire Hazard Severity Zones (VHFHSZ). We therefore authorize submission of a Community Impact Statement (CIS) on CF 10-2468-S2 stating Support, if Amended, and requesting that Council direct LAFD/CFAC/Planning to incorporate the following in their report-backs and any implementing ordinances/guidelines:1) Local tailoring and clarity: Align City guidance with BOF/OSFM rules while allowing site-specific alternatives that achieve equivalent ember resistance. Provide clear plant/material lists and graphics.2) Equity & cost assistance: Identify funding (rebates, grants, fee waivers) for low-income seniors, disabled residents, and small-lot homeowners.3) Biodiversity & water-wise landscaping: Coordinate with CFAC/Urban Forestry/BSL/Sanitation to protect habitat and promote non-combustible. drought-tolerant design beyond 0-5 ft.4) Insurance & real-estate interface: Integrate AB-38 disclosure/real-estate transaction touchpoints and provide standardized inspection/acknowledgment forms that insurers recognize.5) Outreach & phased enforcement: Launch multilingual outreach and adopt a phased timeline with warnings, technical help, and an appeals path before penalties.6) Inter-department coordination: Ensure coherent standards across LAFD, City Planning, Street Services, and Recreation & Parks for park edges, trails, utility corridors, and street trees.

The State, pursuant to Executive Order N-18-25 (Feb 10, 2025), is expediting BOF rulemaking for Zone 0 consistent with PRC §4291 and GC §51182; the City should prepare now to operationalize these rules with clear, equitable, and locally tailored standards. Requested Amendments / Direction: 1) Publish plain-language City guidance synchronized with BOF/OSFM definitions that identifies allowable non-combustible materials and ember-resistant details.2) Provide financial assistance for low-income, senior, and disability-impacted households.3) Coordinate with CFAC/Urban Forestry/City Planning/BSL/Sanitation to protect biodiversity and urban canopy outside the first 5 feet.4) Integrate AB-38 real-estate disclosure touchpoints and standardized inspection/acknowledgment documents for insurance recognition.5) Adopt a phased rollout with outreach, compliance windows, hardship exemptions, and appeal process before any fines.Rationale:Ember-driven ignition is a leading cause of home loss in wildfires. A non-combustible Zone 0 materially lowers structure ignition risk and helps firefighters hold the line during extreme wind events. Aligning City practice with State timelines while addressing equity, biodiversity, and insurance reality is essential to community safety and resilience.
