2. CHAIRPERSON'S REPORT

- a. Congress of Neighborhoods at City Hall on September 27, 2025. Melissa attended the meeting and provided comments about it, including sessions on zero-waste/recycling and emergency preparedness. Melissa appreciated the opportunity to network with other Neighborhood Council members and city representatives.
- b. Monthly Meeting with Ricardo Flores of CD7.
- c. Meeting with ST Forward. Comments were made by Melissa and Ross. Melissa, Leny, Sherry and Cindy commented about Indigenous People's Day and how we can support them in the future.

3. GENERAL PUBLIC COMMENT ON NON-AGENDA ITEMS

- a. Marjorie said they are using funding for plants and November 15th is a planting day (Saturday) if anyone can join; Roger will do a flyer that Outreach can promote.
- b. Ross asked about the newsletter and if his email had been inadvertently deleted because he didn't receive it. Melissa will have Dante check for Ross' email.
- c. Cindy discussed the determination letter for the Verizon 30 ft. tower which is now approved, and the 60 ft. tower for AT&T which we never received early notification for. The 60 ft. tower project people will be invited for the November 10th LUC meeting to present the project, possibly an in-person meeting.
- d. Ross asked if the Board took an official position on Prop 50; Cindy said we did not.

4. ADMINISTRATIVE ITEMS

- a. Motion to Approve Outstanding Minutes. Motion made by Sherry and seconded by Leny. **Vote taken and Motion approved.**
- b. Review and Approve Giveaway Item Proposal - \$5,000 budget approved by the general board on 10/08/25. Melissa went over a draft list of give-aways with prices and pictures. Comments were made by Cindy who thought the items were good. Some items (e.g. First Aid Kit) are too expensive; focus was on the less expensive items. The draft list didn't include shipping/taxes which Melissa will get later. Melissa showed an alternate logo with mountains in the background which might be on the totes. Ross commented that the totes which might be costed in next year's budget. Melissa felt that it might be possible to provide a first aid bag with contents provided separately to reduce the cost/item.
